- 2) Safety Deposit box- contains duplicate keys for P.O. Boxes, as well as the history of Valley Vista
- 3) Water- 17,000 gal. Available, the issue of shut-off valves was raised by Harry Furniss, and discussed. Location of tanks was discussed, and the fact that we have two pumps and extra timers in storage in case of emergencies
- 4) Gate Code- will be changed in approximately two weeks. The gate will stay open when electricity is off. The code maybe changed at any time, if our security is in jeopardy
- 5) Dogs- Please do not allow dogs to run free. Please clean up after them.
- 6) Trees- please have dead/ dying trees removed before they fall on the road. Trees blocking the road are the financial responsibility of the property owner.
- 7) Southern Tree Company was contacted by Dave for estimates of roadside trimming.

Steve Gerber volunteered to help anyone who needs it in the winter, and suggested that the leaves in front of the security camera be trimmed.

Lani Hutchinson stated that we are very blessed to have such good water, and that maybe more speed signs would help slow down the traffic on our road.

Don Zander reminded everyone not to give out our gate code to work/service people who show up at our gate and recommended that the county sheriff should be called regarding stray dogs. Eddie VanVliet suggested placing sand at the switchbacks in the winter, for traction.
